## APPLICATION REQUIREMENTS FOR COMMUNITY CARE DURHAM CLIENT AND FAMILY ADVISORY COMMITTEE:

Community Care Durham would like to hear from individuals who may be interested in becoming a member of the Client and Family Advisory Committee. Each member shall hold office for a term of two (2) years, unless filling a vacancy created by a member leaving before his/her term has expired.

The Client and Family Advisory Committee is comprised of clients, caregivers, and two (2) designated CCD staff (one Management, one Front Line) with a broad range of knowledge, skills and experience. To continue to build and strengthen the diversity of the Committee, the CCD Senior Management Team particularly welcomes applications from individuals with the following (or combination of) attributes:

- A client of CCD
- A caregiver/family member of a CCD client
- A vested interest in ensuring that the work of CCD captures the needs and issues of clients and caregivers
- Able to identify gaps in services and recommendations for new programs
- Able to provide input for strategic planning
- Representative of the varied people groups of Durham Region

Successful applicants will be representative of the varied geographic areas of Durham Region, and will be expected to participate as team players, providing feedback and recommendations to the CCD CEO and designated staff, regarding issues of importance or concern to our clients and their care partners.
